We accept most insurances. However, we are not a participating provider with DSHS (medical coupons) or with any form of Basic or Apple Health or Coordinated Care plans. We ask that you contact your insurance carrier to confirm that our providers (Arinola Dada, MD, FACR or Deepa Gali, MD) are listed as participating in your plan. We require all patients to have a primary care physician (PCP). It is your responsibility to check with your insurance prior to your visit whether there are specific requirements for you to see a specialist. If your insurance requires a referral and one has not been received at the time of service, you may be fully responsible for payment of that visit.

Please bring your insurance card, photo ID and any co-pay that may be due to your appointment. Any out-of-pocket costs will be due at the time of service. We accept:

Please note that cancellations require a minimum of 24 hours' notice to avoid a fee. If you provide less than 24 hours' notice or do not show for your scheduled visit, you will be charged \$200 for the missed appointment per occurrence.
